Hi Missy,

I hope you are enjoying the start of summer as much as possible! We just heard the good news about the Supreme Court and the TRAP law, but imagine it must still be tense in Texas.

We had some admin changes recently but I wanted to be sure to get back in touch with you about starting procurement at the Houston facility. As we discussed previously, this is a great opportunity for your patients, your affiliate, and our clients.

We want to make sure that our specimens are being procured and handled according to our client specifications. We are excited about the opportunity although we do not have a technician available to station in Houston right now.

In discussing more with Susan we think that a good solution right now would be to start a trial period of fetal liver/thymus procurement and we can get to know your and Tram's process better. I've drafted a re-tooled agreement for procurement and compensation—see Exhibit A in attached agreement.
