### **DETAILS OF THE INVESTIGATION:**

On 3/15/2016, California Department of Justice, Bureau of Investigation, Special Investigations Team, Los Angeles Regional Office Special Agent Supervisor (CA DOJ/BI/LARO/SAS) James Hirt and I, SAS Michael Casperson, telephonically (1-877-228-3600) interviewed Dr. Jennefer Russo regarding her contact with David DALEIDEN and Adrian LOPEZ on 2/27/2015 at the Planned Parenthood Medical Director's Council Dinner (MDCD) in Orlando, FL. Dr. Russo was currently the Medical Director of Planned Parenthood for Orange and San Bernardino Counties. At Dr. Russo's request, Beth Parker, Chief Legal Counsel for Planned Parenthood of California was present on the call.

Dr. Russo told me she first met DALEIDEN and LOPEZ at the MDCD when she sat at the same table with them at the request of Dr. Deborah Nucatola. DALEIDEN introduced himself to Dr. Russo using his well-known pseudonym "Robert Sarkis." No further information has been developed regarding the identity of LOPEZ. Dr. Russo remembered that the conversation between her and DALEIDEN and LOPEZ consisted of a description of services Biomax could provide Planned Parenthood. They also discussed Planned Parenthood's fetal tissue donation procedure to biomedical research companies. The only other contact Dr. Russo had with DALEIDEN and/or his associates was a follow-up email from DALEIDEN. In the email, DALEIDEN requested a lunch meeting with her, but Dr. Russo declined the request.

DALEIDEN surreptitiously video and audio recorded the MDCD meeting with Dr. Russo without her knowledge or consent. The video was released to the public via the internet on 3/1/2016. Dr. Russo felt the video was heavily edited and manipulated causing her comments to be taken out of context. Dr. Russo expressed a general fear for her safety because of the release of the video. She advised me that because of this, Planned Parenthood provided her with a comprehensive security detail. The security detail was discontinued on 3/7/2016. Additionally, Dr. Russo contacted the Federal Bureau of Investigation, Los Angeles Field Office, Civil Rights Program after the video was released. Dr. Russo added she was not aware of any current threats to her safety.

This investigation is ongoing.
